## THIRD DISTRICT AMERICAN LEGION AUXILIARY MERIT AWARD

This award is to assist the recipient for a college, university, nursing, trade, commercial or vocational education in a recognized institution.

Each year one or more merit awards will be awarded.

Any member of The American Legion or the American Legion Auxiliary, SAL or their son, daughter, grandson, granddaughter; or the surviving spouse or the son, daughter, grandson or granddaughter (also great) of a deceased veteran is eligible. Applicants must meet all requirements listed below. Instructions and form will be available from any Unit President or Merit Award Chairman. Forms may be copied as necessary.

- 1. The applicant shall submit with their application their name, address, a recent photograph, and the name of the school in which they are enrolled. Applicant must be a high school graduate, and shall submit a transcript of high school grades, rank in class, and a composite score of a standardized test as ITED or a college entrance test. Three letters of recommendation shall be submitted; one from a high school teacher, one from a business or professional person; one additional letter, preferably from the clergy. Letters shall have the following information:
- \* CHARACTER-giving standard of conduct, strength of character, adherence to truth and conscience devotion to daily duties.
- \*AMERICANISM- fine ideals, love of country
- \*ACTIVITIES- describing activities in church, school, community
- 2. Applicant shall submit a letter from the Post Commander or Unit President of the American Legion or Auxiliary from which your eligibility originated. Any student living out of the district who is a member of a Third District organization as SAL or Juniors is eligible to apply.
- 3. Applicant must submit an original essay consisting of not more than 500 words, which will give insight into your personality and express the qualities you want to be known and be remembered by in your chosen field. Please sign this essay.

Winners will be chosen by the District Merit Award Committee and the number of awards will be determined by that committee. In so far as possible, awards shall be to applicants in various locations within the District and will be awarded to the student with their enrollment in the second semester of their freshman year in any school of higher learning.

COMPLETE APPLICATIONS shall be sent by the applicant, all at one time, to the Chairman by the date of APRIL 1, 2020. We encourage applicants to follow all instructions, fill in all spaces and note if not applicable.

Winners will be announced at the Third District Spring Conference.
